Ashland Community Hospital Foundation Welcomes Five New Board Members

ASHLAND – Ashland Community Hospital Foundation is pleased to announce the newest members of its board of directors, who will serve two three-year terms:

Larry Gibbs, Ph.D., is an Associate Professor of Sociology at Southern Oregon University and a Medford resident. He is faculty in Ethnic and Racial Studies and Co-coordinator of the Healthcare Administration program. As a trained family demographer, he uses quantitative and demographic methodologies to investigate issues pertaining to health disparities among various populations.

Larry believes using research is important for community development and has been part of grant funding proposal efforts to assess community health care needs in the Rogue Valley since 2017.

Tiffanie Lambert, Ashland, is Assistant Superintendent of Teaching and Learning at Phoenix-Talent Schools. She serves as logistics lead in the emergency response to the 2020 Almeda Fire in addition to her duties overseeing and managing federal programs, special education services and curriculum. Phoenix-Talent Schools has been critical in the fire response and rebuilding of their community, as well as navigating through the COVID-19 pandemic.

Tiffanie has been an Oregon public educator for 22 years and has served as special education teacher, elementary principal, middle school principal, special education director and curriculum director. She holds a Bachelor of Arts in Education from Washington State University and a Master's in Education in Educational Leadership from the University of Oregon.
